## Proposal to Construct a New Glenvar Library Moves Ahead

On June 8, the Roanoke Co. Board of Supervisors voted to move forward with a proposal to design and construct a new Glenvar Library. Under the proposal, the current Glenvar Library would remain open while the new library was built on the same site. Although the board voted to move forward with the \$6 million project, a public hearing must be held and a second vote taken to appropriate the funding. The public hearing and final vote are scheduled for June 22 at 3:00 p.m. at the Roanoke County Administration Center.

# West Main/Route 460 Widening Project

Widening of the 2.1-mile Route 11/460 corridor just west of Salem to Technology Drive (near Fort Lewis Church Rd.) is scheduled to get underway this year and is expected to be complete by the fall of 2012. The project entails widening the current two-lane section of Route 11/460 to a four-lane divided highway with a raised median and turn lanes. Work also will include constructing a 44-foot-long bridge over Little Bear Rock Branch, adding sidewalks to tie into existing pedestrian routes around Fort Lewis Elementary School, and providing a paved shoulder to accommodate pedestrian and bicycle traffic. In addition, the existing traffic signals at Alleghany Drive and Daugherty Drive will be replaced. A date for construction to begin has not yet been set.

A second Community Meeting will be held on June 29, 2010 at 7:00PM in the Fort Lewis Baptist Church Fellowship Hall. #### Black Bears in Cherokee Hills

With several recent black bear sightings in Cherokee Hills, it's important to keep in mind what's known about bear behavior and appropriate ways to respond. The Virginia Department of Game and Inland Fisheries web site shares, "Black bears are becoming an increasingly common sight in Virginia — bears now live in almost every county! We are fortunate to have a healthy and sustainable population of these animals in the Commonwealth. But even as our black bear population grows and expands, at the same time, residential areas are encroaching into the forested lands and habitats used by bears and other wildlife, thus increasing the chances for bear/human interaction or conflicts." - Put your trash out the morning of pick up rather than the night before,
- Keep grills (and surrounding areas) clean and free from food waste, and
- Reduce or avoid the use of bird feeders in your yard.

# Cherokee Hills Sewer Line Update

A member of the Cherokee Hills neighborhood passed along information to the CHCA Board regarding public sewer service. According to the information received, residents along both sides of Cherokee Hills Drive between Teepee Lane and Sundance Road have the option of buying into the sewer line. The cost is a \$7,500 flat fee. Residents that buy-in also have to pay to have their own sewer system connected to the main line. The sewer line will be installed along the odd-numbered side of Cherokee Hills Drive, but residents along both sides can connect.
